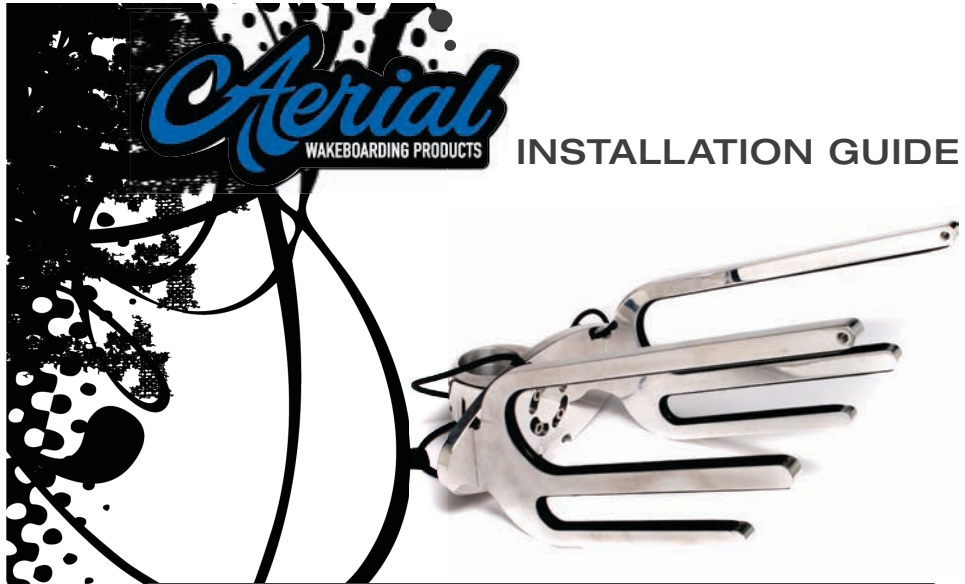

Items purchased through a domestic dealer or international distributor cannot be returned directly to Aerial Wakeboarding. Any duties, freight, taxes, customs fees and installation costs are non-refundable.



AERIAL PRODUCT CARE

- Wash all racks with a mild soap and water.
- Polished Product - use Mothers Mag & Aluminum Polish which can be found at any auto parts store
- Powder Coated Products- no wax, or cleaners can be used
- Check set screws before each use
- Check Allen Bolts before each use

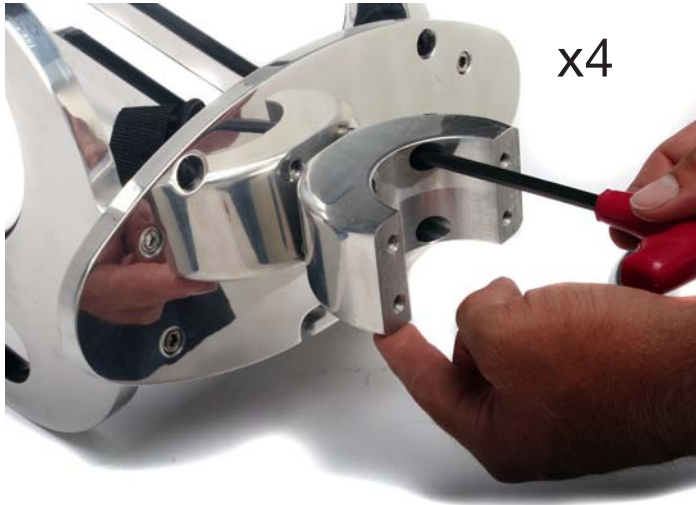

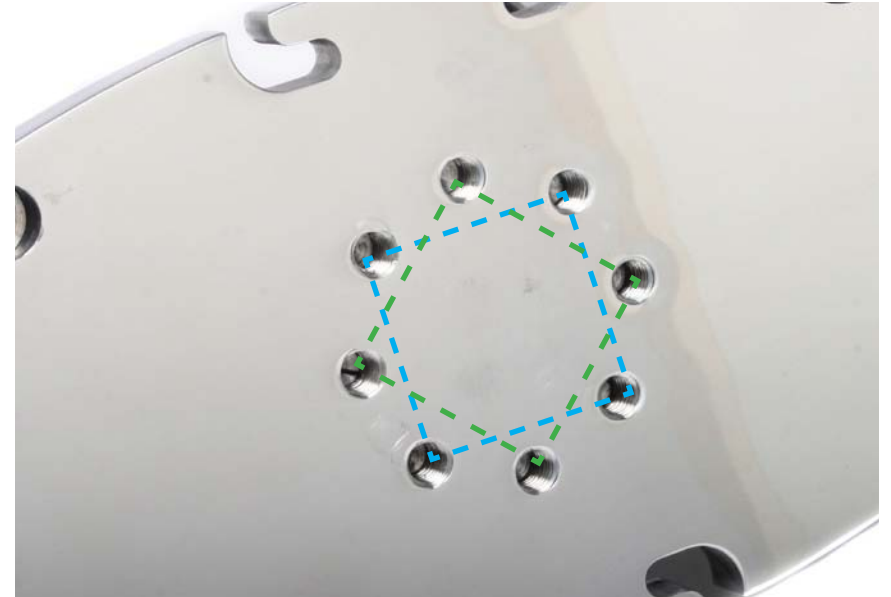
